The data shows that governments must work, on average, four times faster to meet the goal on time.[1] To meet this goal, the U.N. recently announced its Water Action Agenda 2023, intended to accelerate current global projects and rapidly deploy new solutions.

## A major victory for climate-consciousness and impact investing ?

The impact-investment hedge fund Engine No. 1 made a big splash in May 2021 when it managed to get three nominees elected to the ExxonMobil board of directors. It was an open effort to prod the oil giant toward renewable energy and test whether activist investing could make a difference.

A year-plus later, Harvard Business School senior lecturer Mark R. Kramer says it's still an open question.

Investor allocations toward impact investing hit \$1 trillion last year. While investing in companies with social impact is a well-established approach across venture capital and private equity, the concept is newer to public equities and hedge funds. Socially responsible investors have long chosen stock portfolios that align with their personal values, but it is hard to attribute much social impact to owning a publicly traded stock. And, unlike mutual funds, hedge funds more commonly use short selling, investor activism, and other unconventional techniques, giving them ways to influence companies. The high-risk, high-return expectations of hedge funds make achieving impact more difficult, especially within the much shorter time horizon of a typical investment.

Meanwhile, the notion of impact investing was gaining steam in private equity and venture capital. Mostly, early impact investing put capital into companies aiming to solve social problems, like micro-finance and housing.

Unlike typical activists elected to corporate boards, which look to restructure and maximize short-term returns, Engine No. 1 would use its shareholder investment and activism to focus on long-term value creation. Targeting ExxonMobil seemed easy. Beyond the environment, there was a financial case for change to make after a dismal year and the sense that the giant was lagging its peers on environmental issues.

## BRICS and Beyond News

### BRICS Surpasses G7 Countries In Terms Of GDP

At the end of 2022, the BRICS interstate association (BRICS) surpassed the club of G7 countries in terms of GDP. In the global economy, the BRICS had a share of 31.5%, and the G7 – 30.7%.

The incident was commented on his Telegram channel by a Russian expert, economist Konstantin Dvinsky. At the same time, he immediately admitted that it is primitive to assess the state of the country's economy solely in terms of GDP. However, now the “civilized” West and its satellites have lost the opportunity to influence public opinion on this issue, praising their economic system for propaganda purposes.

After all, what is GDP? It is simply the market value of all goods and services produced in the country for end use. – – says Dvinsky.

He explained that GDP will be higher in countries where prices are higher. For example, going to the hairdresser for 100\$ in San Francisco and for 1000. rubles in Saratov is the same service, but the contribution to the statistics will be different, taking into account the difference in exchange rates.

## South Africa to host BRICS summit in late Aug

South Africa will host the BRICS Summit in Gauteng province on August 22-24, said Minister in the Presidency Mondli Gungubele.

Gungubele made the remarks on Thursday while briefing the media about the cabinet meeting on Wednesday, Xinhua news agency reported.

This year's summit will be held under the theme: "BRICS and Africa: Partnership for Mutually Accelerated Growth, Sustainable Development, and Inclusive Multilateralism," according to the Minister.



The BRICS consists of Brazil, Russia, India, China and South Africa. South Africa assumed BRICS chairship on January 1, 2023, taking over from China. More details regarding the summit are anticipated soon.

## Argentina formalizes its BRICS membership application



Argentina has sent a BRICS' formal membership application to Chinese authorities this week. Beijing since last June current holds the chair of the Brazil, Russia, India, China and South African powerful trade and cooperation block.

The submission of the document was celebrated by the Argentine ambassador to China, Sabino Vaca Narvaja, who described the event as a "historic opportunity" for his country since the current bloc members account for 24% of the world's Gross Domestic Product (GDP).

In order to get support to join BRICS formally, the Argentine government had already received the consent from Beijing

(one of Buenos Aires closest political and economic partners), and had made a similar move on India. In effect earlier this year Argentine foreign minister Santiago Cafiero visited India, and last month received in Buenos Aires his Indian counterpart, minister, Subrahmanyam Jaishankar.

Two other BRICS members, Brazil and Russia, have always been positive about the integration of Argentina to the block, which is becoming increasingly demanded.

In effect the waiting list includes Iran, which last June signaled its interest in joining to which must be added in July three Middle Eastern heavy weights, Saudi Arabia, Egypt, and Turkey.

## BRICS Debates Expansion as Iran, Saudi Arabia Seek Entry

The BRICS group of nations plans to decide this year whether to admit new members and what criteria they would have to meet, with Iran and Saudi Arabia among those who've formally asked to join, according to South Africa's ambassador to the bloc.



Enlarging the group that includes Brazil, Russia, India, China and South Africa would benefit Beijing, as the world's second-biggest economy tries to build diplomatic clout to

counter the dominance of developed nations in the United Nations, International Monetary Fund, World Bank and other institutions.

China initiated the conversation about expansion when it was chair last year, triggering concern among other members that their influence will be diluted, especially if Beijing's close allies are admitted. China's gross domestic product is more than twice the size of all four other BRICS members combined. The proposal to expand BRICS will be one of the economic bloc's main focuses this year, said Ambassador Anil Sooklal. South Africa is the group's current chair.

"There are over a dozen countries that have knocked on the door," Sooklal said in an interview in Johannesburg last week. "We are quite advanced at looking at a further group of new members."

## BRICS summit is likely to strongly oppose carbon tax proposed by EU



Brazil, Russia, India, China and South Africa may strongly oppose the proposed Carbon Border Adjustment Mechanism (CBAM) by the European Union at the 13th BRICS Summit on Thursday as the five developing countries will likely be the biggest losers from its implementation.

In a veiled reference to CBAM, BRICS trade ministers last week cautioned that any measure to tackle climate change must be in conformity with multilateral trading rules and shouldn't put arbitrary restrictions on international trade.

"We underline that all measures taken to tackle climate change must be designed, adopted, and implemented in full conformity with WTO agreements and must not constitute a means of arbitrary or unjustifiable discrimination or a disguised restriction on international trade," BRICS trade ministers said in a statement.

Moreover, considering the cumulative contribution of the European Union and the US to CO2 emissions, countries such as China, Brazil, India, and South Africa continue to argue that the primary obligation to reduce emissions falls upon developed countries.
